I began my career at Kokusai Kogyo as a marine engineer, working on DRM solutions for harbors and ports. Since 2013, as president, I oversee our entire range of technological solutions, including DRR and DRM. I have served as liaison to the government emergency task force for every major disaster since the Hanshin Kobe Earthquake in 1995, at local, prefectural, or national level, depending on the disaster.

I learned how DRR and climate change interact in practice and policy, as managing director of a German solar energy company.

During my first term as ARISE Board member, I served on the KPI task team, task teams planning ARISE sessions at GP22 and ARISE AGMs (2022, 2023), worked on the revised ARISE Network Starter Kit. I helped plan, and gave welcoming remarks, at the private sector stakeholder meeting at APMCDRR22, as well as various ARISE Japan meetings and symposiums. I believe I have fully contributed to ARISE and UNDRR during my first Board term as a willing worker and heavy-lifter behind the scenes, and active steering committee member for ARISE Japan.

Yes. **Resilient infrastructure** is one of Kokusai Kogyo's core business areas. I bring my experience in running the technical side of a business that provides technical DRR and DRM solutions. We have multiple technical and senior level people working on resilient infrastructure solutions, and a constantly evolving track record in Japan.

I am serving across various DRR-related industry and business associations in Japan, and have a working relationship with key government and local government actors in DRR. I will advocate for ARISE through these capacities, and bring my knowledge of Japanese DRR experience and good practices to ARISE and the ARISE Board.

Yes. Geospatial information technology is key, in every step of disaster mitigation, response, rescue, and recovery and building back better, and for decision-making when **investing in resilience**, i.e. to all **ARISE priority areas**. We are specialists with high technical capacities.

Geospatial information technology and tools such as GIS are very important for **insurance** (in assessing risk), for early warning, for the design/planning and efficient O&M of **resilient infrastructure**.

I bring, through my position in the company, the capacity to discuss and input in depth, the myriad of soft technology solutions that support and complement resilient infrastructure.

Yes. As noted above, geospatial information technology is Kokusai Kogyo's forte, and we work with both local and national government in the area of **early warning**. Our cutting-edge technology in real-time tsunami damage prediction is part of Japan's national arsenal of **early warning** tools. Aside from governments, we also provide a platform/app that tailors delivery of early warning information to businesses keeping track of many locations. We have shared these examples at GP22 as well as at the ARISE Japan-Philippines Knowledge Sharing Sessions.

We interact daily with our local and national government clients in a close collaboration which is an example of **public-private partnership** at the working level.
